

This form / plea should only be used if at the time you received your citation you were:

1. Operating a motor vehicle without a valid driver's license in violation of the provisions of s. 322.03, s. 322.065, or s. 322.15(1), or operating a motor vehicle with a license which has been suspended for failure to appear, failure to pay civil penalty, or failure to attend a driver improvement course pursuant to s. 322.291. **or**
2. Operating a motor vehicle without a valid registration in violation of s. 320.0605, s. 320.07, or s. 320.131. **or**
3. Operating a motor vehicle without Personal Injury Insurance (PIP) Auto, in violation of s. 316.646.

You must present proof of compliance prior to the scheduled court appearance date for criminal citations or within 30 days of receiving your civil citation. Proof of compliance shall consist of a valid, renewed, or reinstated driver's license or registration certificate and proper proof of maintenance of security as required by s. 316.646.

1. A copy of my valid registration certificate **and**
 2. A copy of my valid Personal Injury Protection Insurance (Insurance card/policy/certificate or binder) **and**
- Payment of \$35.25.

OR

PART C For operating a motor vehicle without Personal Injury Insurance (PIP) Auto

In violation of s. 316.646.

- Proof of compliance consisting of a copy of my valid PIP Auto Insurance (Insurance card/policy/certificate or binder) **and**
- Payment of \$17.40.
